I assume you already understand that at the bottom it says it related to an 18th century transfer or transaction between Colwell Brickenden and John Groom and Griffin and Doghty And it was marked No 4 when shown by Daniel Smith at the time of his examination before Edward Ward.

IMG 502 (I think this is in a later hand than the above document)

At the top is the Title of the document: Inkpen 5th July in the ? year of the reign of Henry (?) – and the last word is Inkpen

Section 1 'Simon Hazelden' [near the end] 'Dolcombe' [place or farm or field]

Section 2 'Thomas Rogey and Johannes Jones'

Section 3 'John Goulesme' and in line 2 'the said John' and 'seneschal' (steward)

Section 4 'John'

Section 5 (which is much longer) line 2 mentions the [manorial court] 'homage' for the first time and the seneschal in that line and the next line. The last line ends with '10 pence'.

Next section line 1 John Young – for giving homage for one? tenement – different kind of number – but 31s!

Final 5-line section Homage by Simon Hazelden Wills [man with 2 surnames, the second having been inserted here, is unusual] who held the Manor of Hazelwick

Line 4 (beginning) '... at (apud) Newbury (?? or another '... bury')' William Fontenoy [?] and Robert Shotsbrooke

Line 5 half-obscured by a finger Simon Wills and John? ... before Simon

IMG 22252 (in an earlier hand than both the above)

Very difficult hand

It is really a list of purchases and ? sales, ie accounts

Section 1 Line 5 refers to wheat ('blad.') and a quantity of 20

Section 2 Line 1 starts 'On every [spot] wheat...'

Section 3 the only line starts 'On 23 eggs {???] bought' and then figure possibly '2s 10 ½ d' (ob is halfpenny)

Section 4 The heading here is 'Expenses...', possibly expenses of the Abbot and starts 'On expenses [1 word in between] of the ? Abbot

Section 5 'In Expenses of the Ballus and others' Ballus might be bailiff.

The scrawl to the righthand side might be a total of some sort or a date.

The next para starts in pale with another reference to Ballus and continues with what must be more expenses

Line 4 starts with 'milling' (molendum)
